The Stewards, having received a verbal report from the FIA Technical Delegate, summoned and heard the competitor Mr. Mohammed ALMEER, have considered the following matter and determine the following:

Facts:

The car was equipped with a manual fire extinguisher, with the expiring date out of date.

Offence:

Breach of ISC Appendix J Article 283.7.2.5

Decisions:

1. **The competitor will be allowed to bring the fire extinguisher in compliance with the regulations. He must present the car for re-scrutineering on 31st of March, latest 10.00 hrs at TC 1.**
2. **If the FIA Technical Delegate will conclude that the fire extinguisher is still not in conformity with the FIA Regulations, the competitor will be disqualified from the event (not allowed to start).**
3. **Reprimand for presenting the car with the wrong fire extinguisher at the pre-rally scrutineering.**

Reason:

The competitor explains that he has rented the car and did not check all equipment. He is aware that he will not start with the fire extinguisher. His team is about to obtain a new manual fire extinguisher in Dubai. This will take some time.

However, according to the CC General Prescription the competitor is responsible for the technical conformity of his car throughout the rally.

The Stewards concluded that the competitor broke the safety regulation of ISC Appendix J Art. 283. If he will replace the manual fire extinguisher and it will be in conformity with the Appendix J Art. 283 at the TC 1 the competitor will be allowed to start. (see CC General Prescription Art. 16.6). The Stewards decision was made based on ISC Art. 11.9.3.f; ISC Art. 12.2.1 and Art. 12.2.2; ISC Art. 12.3.1.k.

The Competitor is reminded of his right to appeal which is stipulated in the 2019 FIA International Sporting Code and in the 2019 FIA Judicial and Disciplinary Rules.


